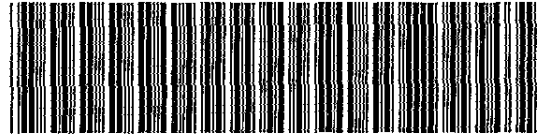

**ARTICLES OF INCORPORATION OF  
R&R DEVELOPMENT OF NORTH FLORIDA, INC.**

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following articles of incorporation:

**ARTICLE I - NAME**

The name of this corporation is R&R Development of North Florida, Inc.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV - CAPITAL SHARES**

The aggregate number of shares which this corporation shall have authority to issue shall be 1000 of a par value of \$1.00 per share.

#### **ARTICLE IX - AMENDMENT**

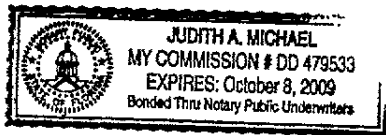
