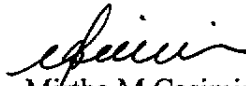

Name of Corporation

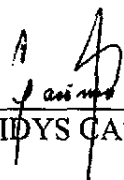
corporation and any subsidiary or controlled company without regard to the fact that he is also a director of such subsidiary or controlled company.

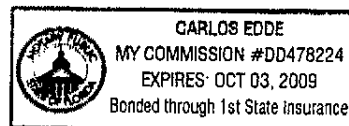
