ARTICLE I - NAME

The name of this Corporation is D & S Site Development, Inc. and the address is 5023 Rock Rose Loop, Sanford, Florida 32771.

ARTICLE II - TERM OF EXISTENCE

ARTICLE III - NATURE OF BUSINESS
