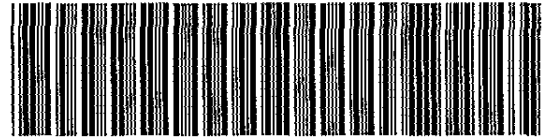

**ARTICLES OF INCORPORATION  
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation is: JOHN D. STEPNES COMPANY, INC., and the purpose for which the corporation is organized to conduct any and all lawful services in the State of Florida.

**ARTICLE II**

The street address of the principal office of the Corporation is: 4308 Montage Drive, Pensacola, Florida 32504.

**ARTICLE III**

The maximum number of shares this Corporation is authorized to issue is 500, par value \$1.00 per share, with 500 shares to John D. Stepnes. All Shares shall be identical with each other in every respect and the holders of said Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

**ARTICLE IV**

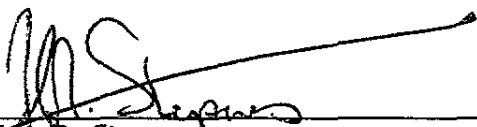

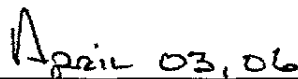

The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.

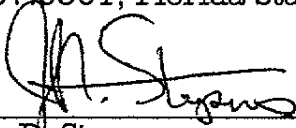
