**ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of RY PROPERTIES, INC., adopts the following Articles of Incorporation to form a for profit corporation under the laws of the State of Florida.

**ARTICLE I**

**NAME**


**ARTICLE IX


