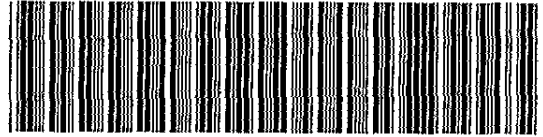



ARTICLE I - NAME

The name of the corporation is CDA of DeFuniak Springs, Inc.

ARTICLE II - DURATION
