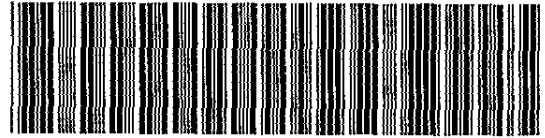



The undersigned subscriber to these Articles of Incorporation hereby forms a Corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: J S TRIM, INC.  
The principal place of business will be 3500 North Honeylocust Dr.

ARTICLE II - DURATION

This corporation shall have perpetual existence.






