ARTICLES OF INCORPORATION
OF
MOBIL DIESEL REPAIR, INC.

ARTICLE I. NAME.

The name of this Corporation is MOBIL DIESEL REPAIR, INC.

ARTICLE II. DURATION.

This Corporation shall have perpetual existence.

ARTICLE III. PURPOSE.

This Corporation is organized to transact and carry on any activity or business permitted under the laws of the United States of America and the State of Florida.

ARTICLE IV. CAPITAL STOCK.

This Corporation is authorized to issue 1,000 shares of one dollar (\$1.00) par value common stock.

ARTICLE V. MANAGEMENT.

A. Pursuant to the provisions of §607.111, Florida Statutes, as the same exists upon the adoption of these Articles of Incorporation, the business of this Corporation may be managed by the shareholders of the Corporation, rather than by a Board of Directors.

B. Should the shareholders of the Corporation so elect, they may by resolution and bylaw establish a Board of Directors to manage the business of this Corporation. In such event, the shareholders shall prescribe the duties, functions and methods of operation of such Board of Directors with particularity and in appropriate bylaws. Initial President and Vice-President of this corporation shall be DAVID L. PATTERSON and MICHAEL C. PATTERSON, respectively.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT.


ARTICLE VIII. PRE-EMPTIVE RIGHTS.




