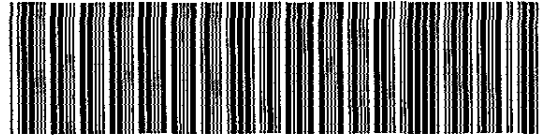

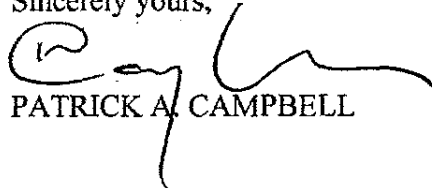

**ARTICLE I  
NAME**

The name of the corporation is Modern Technology Training, Inc. (the "Corporation").

**ARTICLE II

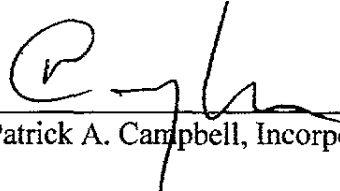
**ARTICLE IX

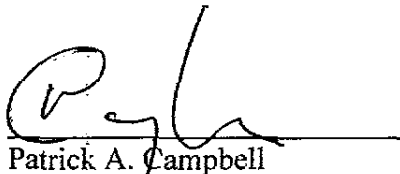
