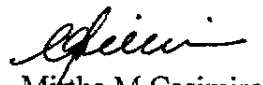

Name of Corporation

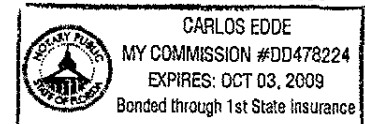
