ARTICLES OF INCORPORATION OF CLEAN STREAK, INC.

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

ARTICLE I Name and Principal Office of Corporation

The name of this Corporation shall be Clean Streak, Inc. The initial mailing address of the Corporation shall be 12760 Cattail Pond Circle, S., Jacksonville, FL 32224.

ARTICLE II Nature of Business

The general nature of the business and activities to be transacted and carried on by this Corporation is to transact all lawful business for which corporations may be incorporated under the Florida Business Corporation Act, as hereafter amended and supplemented, and any successor statute thereto, as thereafter amended and supplemented.

ARTICLE III Stock

The total authorized capital stock of the Corporation shall be 10,000 shares of Common Stock, par value \$.01 per share.

This Corporation shall exist perpetually unless dissolved according to law.

ARTICLE VI Address of Registered Office and Registered Agent
