## ARTICLES OF INCORPORATION

### OF

### Restortek, Inc.

The undersigned incorporators, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation.

### ARTICLE I NAME

The name of the corporation shall be: Restortek, Inc

### ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 5228 Brosche Road, Orlando, Florida 32807.

### ARTICLE III PURPOSE OR PURPOSES

The purpose or purposes for which the corporation is organized are to engage in construction and sub-contracting under licensed contractors. The repair and /or replacement of existing damaged or the enlargement of existing home structures. To do everything necessary, proper, advisable, or convenient for the accomplishment of said purpose and to do all other things incidental to them or connected with them or any other business that are not forbidden by Florida corporation law or by other law, or by these articles of incorporation, and to carry out the said purposes in any state, territory, district, or possession of the United States, or in any foreign country, to the extent that these purposes are not forbidden by the law of the state, territory, district, or possession of the United States, or by the foreign country.

### ARTICLE IV SHARES

The aggregate number of shares of stock and its par value that this corporation is authorized to have outstanding at any one time is: 1000 shares of Capital Stock with a par value of \$1.00 per share.

Initial issue: 100 shares of the Capital Stock of the corporation shall be issued for cash at a par value of \$1.00 per share.

Stated capital: The sum of the par value of all shares of Capital Stock of the corporation that have been issued shall be the stated capital of the corporation at any particular time.

Dividends: The holders of the outstanding capital stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property or in shares of the capital stock of the corporation.

No classes of stock: The shares of the corporation are not to be divided into classes.

No share in series: The corporation is not authorized to issue shares in series.

The initial board of directors and incorporators shall consist of four members, who need not be residents of the State of Florida or shareholders of the corporation.

The names and addresses of the persons who shall serve as directors until the first annual meeting of shareholders, or until their successors shall have been elected and qualified, are as follows:

The Officers and first Board of Directors: Subject to the provisions of these articles of Incorporation, the by-laws and the laws of the State of Florida, the members of the first board of directors and the first officers shall hold office until the first annual meeting of the corporation, or until the first annual meeting of the corporation, or until successors are elected and have been qualified, are as follows:

#### **ARTICLE VI TERM**

which he may in anywise be interested. Any director of this corporation may vote upon any contract or other transaction between the corporation and any subsidiary or controlled company without regard to the fact that he is also a director of such subsidiary or controlled company.
