# **ARTICLES OF INCORPORATION**

### **OF**

#### Restortek, Inc.

The undersigned incorporators, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation.

# **ARTICLE I NAME**

The name of the corporation shall be: Restortek, Inc.

# ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 5228 Brosche Road of plando Florida 32807.

# ARTICLE III PURPOSE OR PURPOSES

The purpose or purposes for which the corporation is organized are to engage inconstruction and sub-contracting under licensed contractors. The repair and /or replacement of existing damaged or the enlargement of existing home structures.
