The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

### **ARTICLE I**

Name, Location and Mailing Address of Principal Office

The name of the corporation is FAST FIX FENCE REPAIR, INC. The principal office and mailing address of this corporation is 3306 Victoria Court East, Jacksonville, Florida 32216.

## ARTICLE II Purpose
