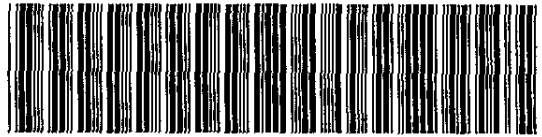

ARTICLES OF INCORPORATION
OF
NGUYEN PRODUCE CORPORATION

I, the undersigned HUNG V NGUYEN whose post office address is: 18850 SW 360 ST, HOMESTEAD, FLORIDA 33034 at least eighteen years of age, do hereby form a Corporation under the provisions of Chapter 607 and/or Chapter 621, F.S. and to that end set forth the following:

ARTICLE 1

The name of the Corporation is NGUYEN PRODUCE CORPORATION (which hereinafter to be called the Corporation).

ARTICLE 2

The principal place of business, the registered office of the Corporation in Florida is 18850 SW 360 STREET, HOMESTEAD, VIRGINIA 33034.

ARTICLE 3

The purposes for which the Corporation is formed and organized are:

- a) To distribute fresh fruits and vegetables as a wholesaler.
- b) To buy, sell, lease, or otherwise dispose of, and to operate, conduct, furnish, equip, and manage and generally to do and perform everything necessary for carrying out the aforesaid purposes.

The Corporation is formed upon the articles, conditions and provisions herein expressed, and subject in all particulars to the limitations relative to corporations, which are contained in the General Laws of this State.
