ARTICLE ONE


The name of the corporation shall be WASTE SOURCE, INCORPORATED (the "Corporation").

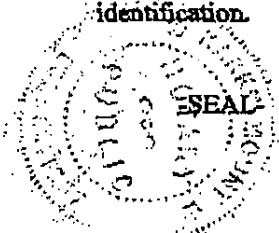
