The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act,
Does hereby adopt the following Articles of Incorporation.

Article 1. Name. The name of the Corporation shall be:

HYPERTEK NETWORK SOLUTION INC

Article 2. Address. The location and mailing address of the principal office of the Corporation is 2807 Dr. MLKing Jr. St. North, Saint Petersburg FL 33704

Article 3. Purpose. The purpose for which the Corporation is organized is to transact all lawful business for which Corporations may be organized under the Florida Business Corporation Act (Florida Statutes Chapter 607)

Article 4. Authorized Shares. The Corporation is authorized to issue one class of shares, which shall be called common shares.
