The undersigned Incorporator hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is **ADRIAN HOMES AT EUREKA PALMS, INC.**

ARTICLE III. DURATION AND COMMENCEMENT
