#### BYRD'S EYE HOME CARE, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of forming a corporation under the Florida Business Corporation Act.

#### ARTICLE ONE Name

The name of the corporation is: BYRD'S EYE HOME CARE, INC.

#### ARTICLE TWO Principal Office

The street address of the initial principal office of the corporation is 20210 1<sup>st</sup> Ave., Panama City Beach, FL 32413.

### ARTICLE THREE Corporate Duration

The duration of the corporation is perpetual.

#### ARTICLE FOUR Purpose or Purposes

The general purposes for which the corporation is organized are:

- 1. To engage in any legal trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on for the benefit of the corporation.
- 2. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

#### ARTICLE FIVE Capitalization

The aggregate number of shares which the corporation is authorized to issue is 1000. Such shares shall be of a single class, and shall have a par value of One Cent (\$0.01) per share, all of which are Common Shares. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
