## **ARTICLES OF INCORPORATION OF**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

### **ARTICLE I: NAME**

The name of the corporation is Blue Marlin Aviation, Inc.
