ARTICLE I. CORPORATE NAME

The name of the corporation is All American Swimming Pools, Inc.. The mailing address of the corporation is 101 Marta Road, DeBary, FL 32713.

ARTICLE II. EFFECTIVE DATE OF CORPORATE EXISTENCE
