ARTICLE XII

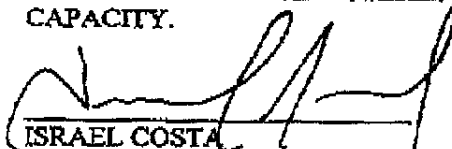
