I. CORPORATE NAME

III. NATURE OF BUSINESS AND POWERS.

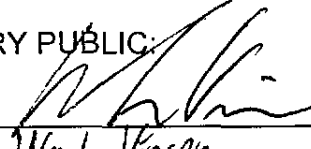
