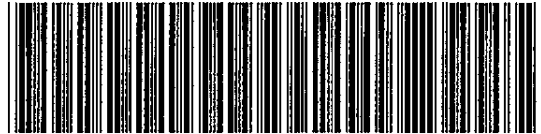





ARTICLES OF INCORPORATION OF J & J

COUNTY, INCORPORATED

In compliance with the requirements of FS Chapter 607, the undersigned being a natural person, hereby acts as an Incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a Business Corporation.

ARTICLE I




