

# AMENDED ARTICLES OF INCORPORATION OF FISH TALE INVESTMENTS, INC.

These Amended Articles of Incorporation are filed pursuant to F.S. 607.0120 and F.S. 607.1006.

The name of the for profit corporation is FISH TALE INVESTMENTS, INC. (the "Corporation"). The Corporation's original Articles of Incorporation (the "Original Articles") were filed with the Florida Department of State on April 19, 2006 and assigned document number P06000055365. The Corporation hereby amends the Original Articles as follows:

### ARTICLE IV. AUTHORIZED NUMBER OF SHARES

The aggregate number of shares the corporation is authorized to issue is five hundred (500) shares of voting common stock. Such shares shall be of a single class and shall have a par value of one dollar (\$1.00) per share.

### ARTICLE VIL

The Corporation reserves the right to amend or repeal any provision contained in the Articles of Incorporation, as amended, and any right conferred upon the Shareholders is subject to this reservation.
