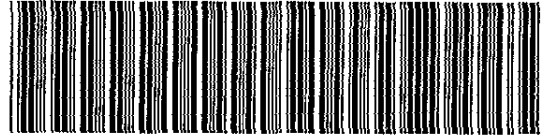



The undersigned, R. C. WHITE, JR., desires to become a body corporate and as Incorporator does hereby make and file these Articles of Incorporation for a proposed corporation pursuant to the laws of Florida, and to that end hereby declares and affirms:

ARTICLE I

The name of this corporation is: **COASTAL CAR WASH PLUS, INC.**

ARTICLE II

This corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III

This corporation shall exist perpetually unless sooner dissolved as authorized by law, and said corporation shall commence its existence on the date of subscription and acknowledgment of these Articles as hereinafter set forth if these Articles are filed with the Department of State within five (5) days exclusive of legal holidays, after such date.
