The foregoing amendment was adopted by the shareholders on October 13 2010, by written consent action.

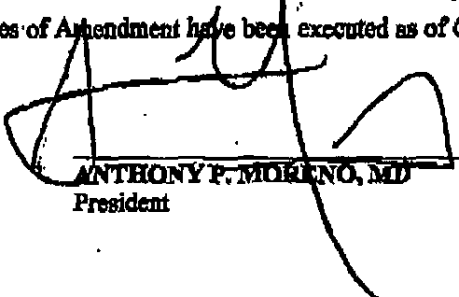
