#### ARTICLES OF INCORPORATION

The undersigned, for the purpose of creating a professional service corporation under the laws of the State of Florida, does hereby adopt the following Articles of Incorporation:

# ARTICLE ONE CORPORATE NAME AND PRINCIPAL OFFICE
