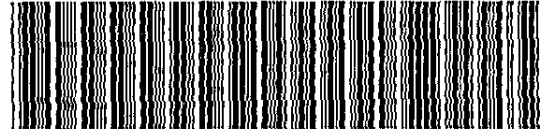

ARTICLE I - NAME

The name of this corporation is N.O.A. Logistics Services Corporation U.S.A.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE
