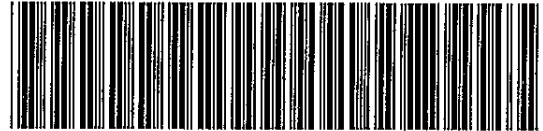

ARTICLES OF INCORPORATION OF

FIRST COASTAL FINANCIAL, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

Article I

The name of the corporation shall be: FIRST COASTAL FINANCIAL, INC.

The initial principal place of business and mailing address of this corporation shall be:



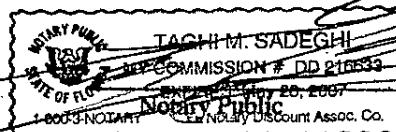
