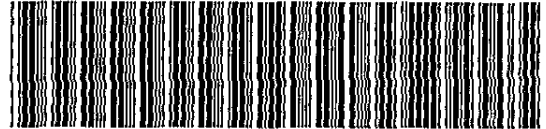

Article Two: Principal Office: The principal place of business and mailing address of this corporation shall be: 2601 Madeline Avenue, Winter Park, Florida 32789.

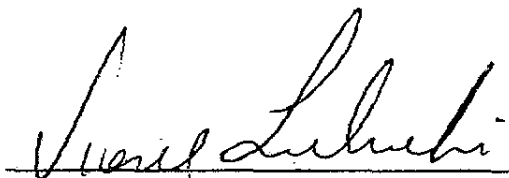
Article Three: Specific Purpose: The purpose of the corporation is to engage in the sale of plastic household wares.

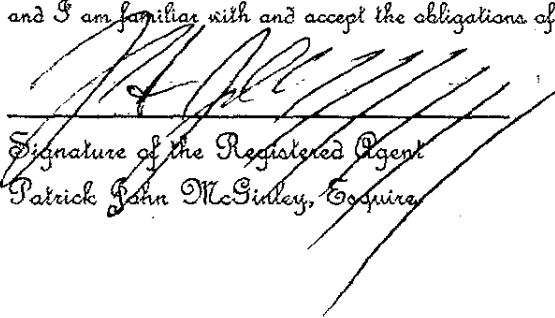
