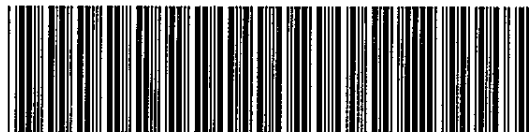

OF

DIRECTORS


The business of the Corporation shall be managed by the Stockholders of the Corporation rather than by a Board of Directors.


