The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, Chapter 607 Florida Statutes (2006), does hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is SOUTHERN BELLE CLAM-BAGS, INC.

ARTICLE II. EFFECTIVE DATE & DURATION

The effective date of the incorporation shall be April 5, 2006, or as soon after that date as the Articles of Incorporation are filed in the office of the Secretary of State. The period of the corporation's duration shall be perpetual or until dissolved on a vote of the shareholders as hereafter provided.

ARTICLE IX. BYLAWS


