The undersigned subscribers to these articles of incorporation hereby associate themselves together to form a Professional Association under the laws of the State of Florida.

ARTICLE I

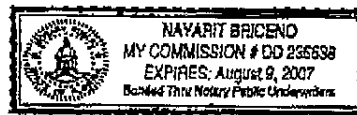

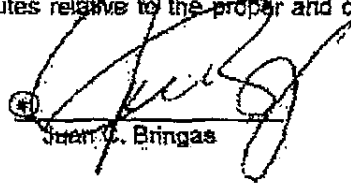
