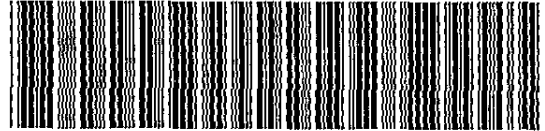



**ARTICLES OF INCORPORATION
OF
PLATINUM HOMES SERVICES, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: Platinum Homes Services, Inc..

ARTICLE II

The street address of the principal office of the Corporation is: 4600 Military Trail, Suite 101, Jupiter, Florida 33458.


