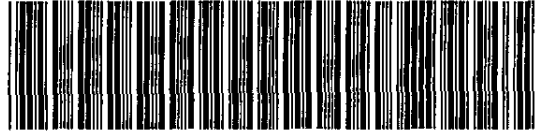

OF

**ARTICLE I.
Name**

The name of this Corporation is: Aeons Centro de Administracao de Empresa, Inc.

**ARTICLE II.

The power to adopt, alter, amend or repeal bylaws shall be vested in the board of directors of the Corporation.

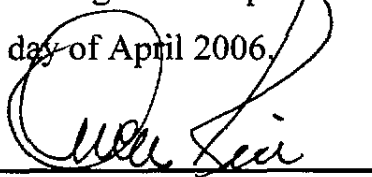

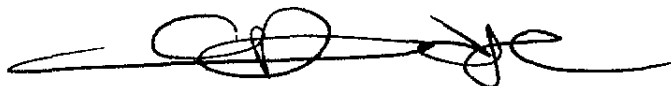
