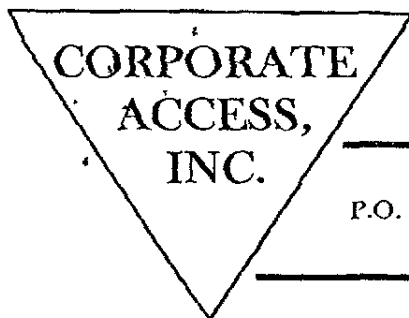

Article I




The private property of the stockholders of the corporation shall not be subject to the payment of corporate debts to any extent whatsoever.
