This communication is to explain why the report and filing fee are arriving after the May 1<sup>st</sup> Deadline for your processing. Extensive time was spent in attempting to access and utilize your electronic filing service on your website (<a href="www.sunbiz.org">www.sunbiz.org</a>). In fact the time spent was in excess of 3 hours both during normal business hours and also after 5:00 PM. All efforts were met with continual error messages apparently stemming from problems with your server/website. Enclosed you will find examples of the 3 different types of error messages that were encountered literally hundreds to thousands of times. During the hours of attempting to complete the annual report filing I called (850-245-6056) and talked to one of your examiners – Tina – explaining the problems that I was encountering and she told me "...the website is fine, there are just a lot of people using it so keep trying...". I continued to do so for several hours with no success.

This lengthy discourse explains why the annual report is being filed after the May 1<sup>st</sup> deadline. Obviously all reasonable attempts were made to file this report timely and through no fault of the taxpayer, we were thwarted in doing so. Therefore, we have submitted the required filing fee and expect that any potential penalties would be waived because of the problems on your website/server.
