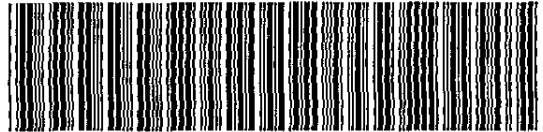



**Article I - Name**

The name of this corporation is **FIRST ULTRASOUND, INC.**, and its principal office is located at 100 Crispin Street, Merritt Island, Florida 32952. The mailing address of the corporation is P.O. Box 542086, Merritt Island, Florida 32954.

**Article II - Duration**

This corporation shall exist perpetually. The date of commencement of corporate existence shall be the date these articles are filed with the Secretary of State.


