# Articles of Incorporation Of *1<sup>st</sup> Line Protection & Investigations, Inc.*

## ARTICLE I – NAME

The name of this corporation is: 1<sup>st</sup> Line Protection & Investigations, Inc.

## ARTICLE II – DURATION

This Corporation shall have perpetual existence commencing on the date of execution and acknowledgement of these Articles.

## ARTICLE III – PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business.

## ARTICLE IV – CAPITAL STOCK

This Corporation is authorized to issue five hundred (500) shares having a par value of \$1.00 per share. Each of the said shares of stock shall entitle the holder thereof to one (1) vote at any meeting of the shareholders.

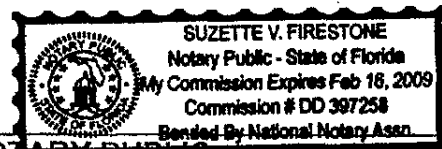
