# ARTICLES OF INCORPORATION OF ALEX GARRIDO, P. A.

#### ARTICLE I

The name of the corporation shall be: ALEX GARRIDO, P.A.

### ARTICLE II

This corporation shall have perpetual existence.

#### ARTICLE III

The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States and of Florida. The general nature of the business to be transacted by this corporation shall include, but shall not be limited to, the following:

- A. To engage in the sale, purchase, rent, lease, management and/or mortgaging of real estate.
- B. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

## ARTICLE IV

The maximum numbers of shares of stock shall be 500 of the par value of One Dollar (\$1.00) per share, all of which shall be common stock.

#### ARTICLE V

The principal office of the corporation shall be located at 750 EAST 48<sup>TH</sup> STREET, HIALEAH, FLORIDA, 33013, but the corporation shall have the power to establish branch offices and other places of business at such other places within or without the State of Florida as may be determined or deemed expedient.

## ARTICLE VI

Every shareholder, upon the sale for cash of any new stock of this corporation shall have the right to purchase his pro-rate share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

#### ARTICLE VII

Initially, this corporation shall have one Director who shall serve until his successor(s) shall be elected/appointed at the first meeting of the stockholders and thereafter this corporation shall have no less than one (1) director constituting the initial Board of Directors. The number of directors may be either increased or decreased from time to time by the Bylaws. The name and address of the initial director is as follows:

The corporation shall indemnify any officer or Director or any former officer or Director, to the full extent permitted by law. No officer or director shall be personally liable for monetary damages to the corporation or any other person for any statement, vote, decision, or failure to act regarding corporation management or policy unless that officer or director breached or failed to perform his duties as an officer or director as provided by Florida Statute 607.0831.

#### ARTICLE XI

The corporation reserves the right to amend, after, change, or repeal any provision contained in these Articles of Incorporation in the manner now or hereafter described by

Statute, and all rights conferred upon the stockholders herein are subject to this reservation.

### ARTICLE XII

If all directors severally or collectively consent in writing to any action taken or to be taken by the corporation, and the writings evidencing their consent are filed with the Secretary of the corporation, the action shall be as valid as though it had been authorized at a meeting of the Board of Directors.
