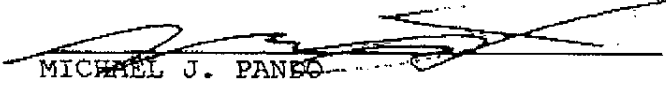

ARTICLES OF INCORPORATION OF

1. Name. The name of the corporation is: CAMEO'S AT WINTERWOODS, INC.
