ARTICLES OF INCORPORATION
OF
CRESCENDO PROPERTIES & DEVELOPMENT, INC.

In compliance with the requirements of Ch. 607, Florida Statutes, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

Article I

The name of the Corporation ("Corporation") is CRESCENDO PROPERTIES & DEVELOPMENT, INC.

The existence of the Corporation shall begin on the date these articles of incorporation are filed with the Department of State.
