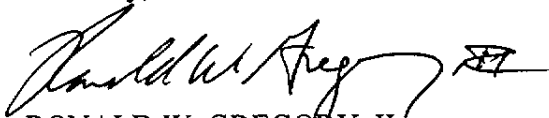
Dear Sir or Madam:

Pursuant to provisions of Section 607.1006 of Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: ARTICLE I is hereby amended to change the name of the corporation from **MEJIA PROPERTIES, INC.** to **KARA MEJIA, P.A.** such that ARTICLE I shall state:

ARTICLE I: NAME

"The name of the corporation shall be: **KARA MEJIA, P.A.**"

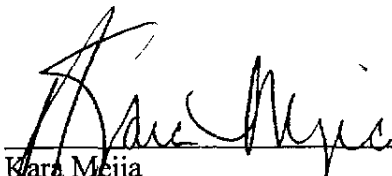
SECOND: ARTICLE III is hereby amended to change the purpose for which the corporation is organized.

ARTICLE III:

"This corporation is organized for the purpose of rendering professional services as authorized by Chapter 475 of the Florida Statutes related to transacting for compensation or valuable consideration directly or indirectly paid or promised, expressly or impliedly, or with an intent to collect or receive a compensation or valuable consideration therefor, appraises, auctions, sells, exchanges, buys, rents, or offers, attempts or agrees to appraise, auction, or negotiate the sale, exchange, purchase, or rental of business enterprises or business opportunities or any real property or any interest in or concerning the same, including mineral rights or leases."

THIRD: This amendment was adopted on May 4, 2006, by unanimous approval of all shareholders. The number of votes cast for the amendment was sufficient for approval.
