Pursuant to provisions of Section 607.1006 of Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: ARTICLE I is hereby amended to change the name of the corporation from MEJIA PROPERTIES, INC. to KARA MEJIA, P.A. such that ARTICLE I shall state:

ARTICLE I: NAME

"The name of the corporation shall be: KARA MEJIA, P.A."

SECOND: ARTICLE III is hereby amended to change the purpose for which the corporation is organized.
