# ARTICLES OF INCORPORATION OF ALICIA NORWOOD & VICTORIA GONZALEZ. INC.

The undersigned subscribers to these Articles of Incorporation, each a natural personal competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

#### **ARTICLE I - NAME**

The name of this corporation is ALICIA NORWOOD & VICTORIA GONZALEZ, INC.

### ARTICLE II - NATURE OF BUSINESS
