ARTICLES OF INCORPORATION

of

CAMILA MEDICAL SERVICES, INC.

ARTICLE I - NAME

The name of this corporation is: CAMILA MEDICAL SERVICES, INC.

ARTICLE II - DURATION

This corporation is to exist perpetually. It shall commence its existence on April 21, 2006

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all business permitted under the laws of the United States of America and the laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue up to ONE HUNDRED THOUSAND (100,000) shares of common stock with a par value of ONE and NO/100 (\$1.00) Dollar each.

Shares may be issued for such consideration as is determined from time to time by the stockholders.

This power which is hereby reserved unto the stockholders by right, may, and it is hereby delegated, unto the Board of Directors.

Shares may not be issued until the full amount of the consideration therefor has been paid. When payment of the consideration for which shares are to be issued shall have been received by the corporation, such shares shall be deemed to be fully paid and nonassessable.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.


