

ARTICLES OF INCORPATION OF

SECRETARY OF STATE TALLAHASSEE, FLORIDA

Intelligent Investments, Inc

ARTICLE I

The name of the Intelligent Investments, Inc.

ARTICLE II

Its initial registered office and principal office in the State of Florida is 4015 Bayshore Blvd 9A Tampa, FL, County of Hillsborough. The name of the initial registered agent at such address is Michael Canfield.

ARTICLE III

The nature of the business or purposes to be conducted or promoted is to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

ARTICLE IV

The total number of shares of capital stock that the Corporation shall have authority to issue is 1,000 all of which are to be common stock with a par value of \$.01 per share.

ARTICLE V

ARTICLE VI

The corporation is to have perpetual existence.

ARTICLE VII

The private property of the stockholders shall not be subject to the payment of corporate debts.

ARTICLE VIII
