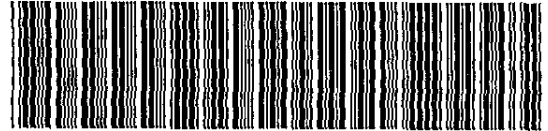

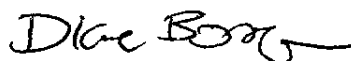

ARTICLE I - NAME

The name of this corporation is Jenkins Towing & Recovery, Inc. (the "Corporation").

ARTICLE II - PRINCIPAL OFFICE

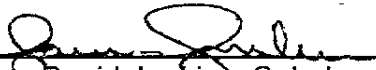
