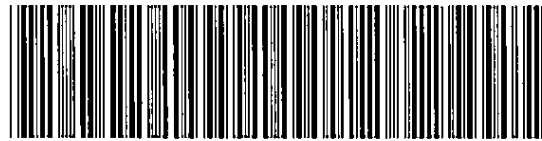

**FINAL ORDER GRANTING MOTION FOR ENTRY OF AN ORDER GRANTING  
FINAL JUDICIAL DISSOLUTION, AUTHORIZING FINAL DISTRIBUTIONS  
AUTHORIZING RELEASE OF RECEIVER'S BOND AND CLOSING CASE**

THIS CAUSE came before this Court in West Palm Beach, Florida for hearing on August 18, 2021 at 8:30 a.m. upon the *Motion for Entry of Order Granting Final Judicial Dissolution, Authorizing Final Distributions, Authorizing Release of Receiver's Bond and Closing Case* (the "**Motion**") filed by The Watershed Treatment Programs, Inc. (the "**Watershed Parent**"). A Abuse Addiction Agency, Inc., A Basis for Recovery Inc., Boca Palms Medical Associates, Inc., JMC Medical Associates, Inc., The Watershed Apartments, Inc., The Watershed at Clear Lake, Inc., The Watershed Residence, Inc., and WS Danna Street, Inc., (collectively, the "**Subsidiaries**" and together with the Watershed Parent, the "**Receivership Estates**"). The Motion was served on all known creditors and parties in interest, and no objections were filed or asserted at the hearing.

Accordingly, it is

ORDERED AND ADJUDGED as follows:

1. The Motion is GRANTED.
2. The Petitioners are hereby dissolved effective August 31, 2021.
3. The final distributions to unsecured creditors, as set forth in the Motion and Schedule 2 attached to the Motion (the "Final Distributions"), are APPROVED. Any party that does not have a claim on Schedule 2 (i) will not, with respect to any such claim, be treated as holding an allowed claim against the Receivership Estates, (ii) will be

forever barred, estopped and enjoined from asserting any claim against the Receiver or the Receivership Estates, and (iii) will not receive any distribution on account of such claim.

4. After making the Final Distributions, the Receiver shall file a notice of completion with the Court (the "Notice of Completion"), and upon such submission shall be discharged from his duties in this matter, and is released from any claims or demands of any interested persons.

5. Upon filing of the Notice of Completion, the Receiver's bond may be cancelled and released.

6. This case is dismissed, with the Court reserving jurisdiction over any issues relating to the interpretation, enforcement or implementation of this Order.

7. The Receiver shall certify service of this Order upon all creditors and parties that have been served with the Motion.
